Who we are

Equiduct is the leading pan-European retail focused exchange built around the specific needs of the retail community. It also provides high-quality cost-effective market data and insight products for both the retail community and institutional clients alike.

Created in 2009 to specifically help brokers and their clients achieve Best Execution and overcome the challenges of fragmentation, all whilst still accessing pan-European liquidity through a single exchange connection, Equiduct became the only trading venue in Europe which was built from the ground up in response to the challenges faced by the retail investment community.

Through its unique market model, Equiduct enables the retail investment community to achieve Best Execution in Europe's most liquid Equities and ETFs across 13 European markets and 18 leading indices.

A market segment of Börse Berlin, Equiduct operates under Article 44 of MiFID II and is regulated by the Senatsverwaltung für Wirtschaft, Energie und Betriebe – Börsenaufsichtsbehörde. In 2024, Equiduct reported 35 active retail brokers, 15.2 million trades executed and a turnover of €85 billion.

1 What stocks are available?

A total of 21 US stocks are available for trading via Apex. These are some of the hottest stocks traded by retail investors worldwide. See the full list on the next page with details of which settlement segments they are available in.

2 What currency are they traded in?

These US stocks are initially being traded in euros (EUR), with stocks being offered in US dollars (USD) at a later stage (timeline to be confirmed).

3 How is the VBBO calculated for the US stocks?

VBBO price formation is calculated by taking liquidity, when available, from Xetra, Borsa Italiana, Turquoise, Euronext Paris and the London Stock Exchange.

4 What does post-trade look like?

All stocks can be cleared by EuroCCP, SIX X-Clear, LCH Ltd. Settlement can either be done in Monte Titoli in Italy or in Clearstream Banking in Germany (see post-trade table on page 4).




5 Are trading hours being extended?

Not initially. We will look into the possibility of extending our trading hours to cover both the European and the US cash markets at a later stage

6 What are the fees for trading US stocks on Apex?

There are zero execution fees for retail orders trading US stocks on Apex. **Yes, zero.**
